2022 FINANCIAL REGULATIONS REVENUE REPORT

MINISTRY OF INTERNAL AFFAIRS

1. INTRODUCTION

The Ministry of Internal Affairs (MoIA) is responsible for putting in place the major policies concerning the internal administration of the country. It aims at improving governance by ensuring that all provincial headquarters are providing coordinated services to the people via Area Council Secretaries and Municipal Wards. Among its roles, it has to ensure that the electoral office, the civil status, and the passport services provide good identity control for planning and budgeting. Another one of its tasks is making sure that immigration and labour services continue their critical role of border control. Improving security and border services as well as providing better access to those services is also high priority for the Ministry. It is also responsible for government-funded project planning and implementation and for the coordination and implementation of those funded by donors at the local levels. Religious affairs and NGOs operations are closely monitored by the Ministry.

The Ministry is composed of the following departments:

- The Department of Local Authorities which is responsible for the administration and supervision of the Provincial and Municipal councils;
- The Department of Immigration which is in charge of the immigration status regulations and of making sure that the border controls are effective and secure; The Labour Department is ensuring the new labour laws are compliant with the international labour standards;
- The Electoral office supervises the registration of the electors and conducts all elections in Vanuatu;
- The Department of Civil Status is registering all the legal events such as registration of Births, Marriages, Deaths and Foetal Deaths, under the laws of the Republic of Vanuatu CAP 60 Marriage and CAP 61;
- The Vanuatu Police Force was established to enforce law and order and to maintain security to the country, its people and properties and development.

The following report aims at analysing the Ministry's revenue performance in the financial year 2022.

The Ministry of Internal Affairs' initial revenue budget for the year 2022 was **VT 1.18 billion**. This is **3.4 percent** of the total budgeted national revenue. The major contribution to this revenue is Residency permits, followed by Passport fees, Work permits and Honorary Citizenship Program Fees which makes it different from last year. Table 1. Describes the percentage of revenue attributed to each department of the Ministry for the year 2022.

From this table we can see that the Department of Immigrations is the main contributor to the annual revenue as it collects over **50 percent** of it, followed by the Department of Labour which collects **26 percent** of the total revenue target.

2022 REVENUE UPDATE:

Figure 1. below shows cumulative revenue budget for the Ministry of Internal Affairs (MoIA) for each progressive quarter against the actual revenue collected.

At the end of 2022, the Ministry of Internal Affairs (MoIA) collected **VT 1.025 billion** which is **86.8 percent** of its budget target.

Figure 1. MoIA Cumulative Quarterly Revenue Budget vs. Actual




Figure 2. MoIA non-cumulative Quarterly Revenue Budget vs. Actual




Figure 2. Depicts the Ministry's non-cumulative quarterly revenue performance. As opposed to last year, the actual revenue is different from the budget. While the budget was expecting inflows on the first, second and fourth quarters of the year, the actual revenue was the highest in the third one.

2. GENERAL DISCUSSION: REVENUE COLLECTION BY DEPARTMENTS WITHIN MOIA

Annex 1 of this report provides an overview of the specific revenue collected within MoIA in the 2022 financial year.

Revenue Collections by individual Departments within MoIA are presented in the following table.

2.1 Civil Registry Office

The Department of Civil Status had a budget of **VT 102.3 million** in the year 2022. However, the actual revenue collected at the end of the year was **VT 124.6 million**. The department exceeded its predicted Revenue target by **22 percent**. The major part of this revenue is derived from the Honorary Citizenship program fees, which represents **91 percent** of it. The other item collecting a significant amount of revenue is the Registration Charge recovery, although it is way less significant than the Honorary Citizenship program. To conclude, the department has performed well and above expectation in 2022.

2.2 Department of Immigration

The Department of Immigration is the one collecting the biggest share of the revenue of the Ministry. In total, the Department's budget was set to **VT 593.6 million** in 2022 which was slightly overestimated by **VT 3 million**. Collections from residency permits and passport fees were the main revenue items within this Department, both of which are related directly to the Honorary Citizenship Program fees and receipts from passport booklets sales. The two sources of revenue were well budgeted as the actual amounts are very close to what was predicted. They respectively raised **VT 385 million** and **VT 154.6 million**. Passport fees were slightly lower than during the previous year, while Residency permits surpassed the 2021 revenue by **VT 137.2 million**.

The 2022 collection has resulted in a **VT 3 million** shortfall in the overall department actual revenue for financial year 2022.

2.3 Department of Labour

Work permits is the most important revenue category of the Department as it brought in **81 percent** of the actual revenue. It is followed by Application Charges Recoveries -

which includes application permit charges, work permit exemption and religious institution work permits -, temporary permit, business licenses and registration (this is employment agency application fee) and other fines (spot fines).

The Department's actual revenue collected at the end of 2022 was of **VT 178.8 million** against a budget of **VT 305.9 million**, which represents only **58.5 percent** of the expected revenue.

2.4 Department of Provincial Affairs

The Department of Local Authorities (Provincial Affairs) of the Ministry of Internal Affairs is responsible for overseeing the local governments, which are divided in six provincial

councils and three municipal councils. While the local governments can alter the fees charged for various services, it has no authority over the level of taxes. The Department planned to collect **VT 98,144** in total but the actual revenue was about **8 times higher** than the forecast, with a total of **VT 812,968**. Still, this department is the smallest one in terms of revenue.

2.5 Electoral Office

The Vanuatu legislative framework sets out for an independent electoral management body composed of two separate but inter-related institutions: the Electoral Commission (EC), a policy-making, oversight body, and the Vanuatu Electoral Office (VEO) which is the operational arm of the EC. The VEO collects Election fees from individuals wishing to stand for different elections. In 2022, the VEO was predicted to collect an annual budget of **VT 3 million** which would mainly rely on election fees. Actual collections at the end of 2022 reached **VT 26.9 million**.

2.6 Internal Affairs Cabinet

The Public Land Transport Authority (PLTA) is part of the Internal Affairs Cabinet and controls the operation and management of public land transport in Vanuatu, and it collects driver's permits fees and penalties. It is also the agency collecting the largest share of the revenue for the Cabinet through Land Transport Permit Fees (88 percent of the revenue). The whole department is forecasted to collect VT 45 million in 2022. At the end of the year, the Cabinet managed to collect **VT 32.7 million**. It is possible that a lot more revenue potential still lies under this agency and a stronger compliance plan should be able to bring in additional revenue, in particular from those who have not been honest in paying their respective fees such as the permit fees.

2.7 Vanuatu Police Force

The Vanuatu Police Force (VPF) is mandated in the Police Act CAP 105 with the core functions of preserving peace and maintaining order, protecting life and property, enforcing laws and preventing and detecting offences and production of offenders before the courts. The Regulations of the Police Act prescribe for fees to be charged for special duties performed.

Police clearance fees by far the category bringing the most revenue within VPF. Traffic Fines and Driving licenses are respectively the next most budgeted items. With the high demand of workers in the Regional Seasonal Employment scheme, and the high number of Vanuatu citizens travelling overseas, the demand

for police clearance documents have recently increased. In 2022, the VPF only collected **53.7 percent** of its target budget. Initially the VPF has forecasted to collect **VT 131.2 million** in total revenue however it ended up collecting only **VT 70.5 million** as total revenue, which is only about half of the predicted revenue.

CONCLUSION

Overall, the Ministry of Internal Affairs revenue collections has collected **95.6 percent** of its budgeted target in 2022. This is an expected outcome given the persistent challenges that the COVID 19 has imposed.

The Ministry of Internal Affairs and its departments have a lot of potential in revenue generation given the nature of the services they provide. However, compliance remains one of their biggest challenges. It is felt that if these areas a strengthened, the Ministry should be able to see an ongoing increase in its revenue collection annually.
