



Press Release: **GOVERNMENT SIGNS AMENDMENT TO NISCOL CONCESSION AGREEMENT**

Luganville, Santo – 3rd July 2025 | The Government of the Republic of Vanuatu, through the collaborative leadership of the Deputy Prime Minister and Minister of Finance, the Minister of Internal Affairs, and the Minister of Infrastructure and Public Utilities, and witnessed by the Minister of Lands, today officiated the signing of the Amendment to the NISCOL Concession Agreement. The ceremony was held at the NISCOL compound in Luganville.

Delivering his official remarks, the Minister of Internal Affairs described the occasion as “*more than just a formality*”, affirming that the agreement is a reaffirmation of a shared commitment to responsible, transparent, and productive port operations in the northern provinces.

“*Ports are the heartbeat of island economies,*” the Minister stated. “*They connect our islands to markets, supply chains, and essential services that support the well-being of our people.*”



He emphasized that the Addendum to the Concession Agreement is the outcome of thorough consultation, reflection, and negotiation, and that it ensures the partnership between the Government and NISCOL continues to serve the interests of the people of northern Vanuatu.

The original NISCOL Concession Agreement, granted in November 2015, remains valid for a 50-year term. The amendment signed today does not extend the concession period, but rather introduces improvements designed to enhance the performance, accountability, and governance of the company.



The amendment includes the following key provisions:

- Expands NISCOL's business activities beyond stevedoring, enabling it to engage in additional commercial ventures.
- Allows for increased investment in company assets and human resources.
- Grants authority to manage other neighbouring wharfs, including **Litzlitz Wharf**.
- Provides flexibility in working hours and the recruitment of new staff to support operational demands.
- Clarifies NISCOL's obligations regarding wharf management.
- Strengthens internal governance structures to enhance performance and ensure profitability for shareholders.

The Minister highlighted the alignment of this amendment with national objectives under the **National Sustainable Development Plan**, especially in the areas of:

- Infrastructure and service delivery,
- Good governance and transparent public-private partnerships, and
- Empowering provincial and local economic participation.

This signing marks a significant milestone in the Government's efforts to enhance port operations and public-private partnerships in Vanuatu. It represents not the final destination, but a critical step toward a future where our ports are managed in a modern, efficient, and accountable manner—delivering shared value for all ni-Vanuatu. The Government expresses its confidence that this amended agreement will serve as a model for future collaborations, founded on mutual respect, transparency, and inclusive economic growth for our provinces and people.
