

Groundbreaking Ceremony for Havannah Harbour Marine Project





A groundbreaking ceremony at Havannah Harbour, North Efate, has marked the start of a major marine development project aimed at boosting Vanuatu's tourism and maritime industries. The Ministry of Internal Affairs, represented by Director General Mr. Leith Veremaito and DUAP Director Mr. Jeffrey Kaitip, joined community members and project partners to celebrate the launch.





A partnership between Havannah Haven Limited, Vanuatu Zipline Ltd, and the Marina Development Company, the project aims to combine economic growth with sustainable practices, creating opportunities for both the marine sector and the local community.

The development will provide advanced haul-out facilities, cyclone-protected berths, and a ZERO discharge marina accommodating over 200 yachts, alongside limited commercial opportunities for hotels and businesses. Havannah Harbour's natural deep-water shelter, rich history with the Lapita people, and World War II heritage make it an ideal location.

Minister Hands Over Electricity Concession Dividends to Sanma Authorities

The Minister of Climate Change and Energy, Hon. Ralph Regenvanu, has handed over dividends from the Santo electricity concession to the SANMA Provincial Government Council (SPGC) and the Luganville Municipal Council (LMC). The payments, covering 2019 - 2023, totaled VT 7,893,933 for SPGC and VT 5,262,622 for LMC, representing their share of the 2% concession fee paid by Vanuatu Utilities Infrastructure (VUI)

Following a Council of Ministers decision in April 2024, the concession fee is now shared 50% to the Government, 10% to LMC, 10% to SPGC, and 30% to the Fanafo Area Council. The funds are intended to support local development priorities, with SPGC and LMC reaffirming their commitment to align activities with the National Sustainable Development Plan.

Sandleng Confirmed as Physical Planning Area in South Pentecost



A final consultation with the landowners of Sandleng, South Pentecost, has concluded with a custom ceremony confirming their agreement for the area to become a Physical Planning Area (PPA)





This decision paves they way for the Provincial team to move forward with plans to develop Sandleng into an economic hub for Penama Province.







Shefa Provincial Government Leads Mission to Tonga



The Shefa Provincial Government Council led a mission to Tongoa Area Council from 12 to 16 May 2025, bringing together the Department of Forestry, Department of Agriculture, Department of Livestock, Vanuatu Primary Producer Authority (VPPA), and the FAO project representative. They were joined by Area Administrators, Area Secretaries, and law enforcement officers from Tongoa.

The mission rolled out the Physical Plan Zone under the Tongoa Ecosystem Restoration and Sustainable Land Management Project, while also distributing farming tools to local communities. Chiefs and people of Tongoa expressed their readiness to support the initiative. The team also registered farmers who will benefit from activities led by the respective government departments under the Ministry of Agriculture, Livestock, Forestry and Fisheries (MALFF).

Foreshore Development Training Workshop Underway in Sanma

The Foreshore Development Unit (FDU) has launched a three-day training workshop at the Sanma Provincial Government, with participation from staff of the Sanma Planning Unit and Luganville Municipal Council. The training focuses on strengthening knowledge of the Foreshore Development Act, standard operating procedures, permit application process, site inspections, and data collection using Kobo Toolbox.



Day one covered the legal framework and application process, while the remaining sessions will focus on practical field exercises. Sanma Secretary General Mr. Lavare emphasized the importance of FDU's support, noting that many upcoming developments will require Foreshore Development Permits to ensure compliance with national laws.





CRIM Launches New National Civil Registration System - RV5

The Ministry of Internal Affairs, through the Department of Civil Registry and Identity Management (CRIM), has officially launched **RegisterViz5 (RV5)**, Vanuatu's new Civil Registration and issuance of National ID Cards, as well as birth, marriage, and death certificates.

RV5 strengthens accuracy, security, and efficiency in civil documentation and also supports the Vanuatu Electoral Office (VEO) by enhancing the integrity of voter registration and protecting citizen's electoral rights.



The system was developed with the support from UNDP through the Vanuatu Electoral Environment Project, funded by New Zealand's Ministry of Foreign Affairs and Trade.



This milestone marks a new chapter in public service delivery and reaffirms the Ministry's commitment to building a secure, inclusive, and technology-driven identity system for all ni-Vanuatu citizens.

Tripartite Labour Advisory Council Reviews Key ILO Instruments

The Tripartite Labour Advisory Council (TLAC) held its First Extraordinary Council meeting on the 30th of May 2025, to discuss urgent International Labour Organization (ILO) Conventions, Protocols and Recommendations.







During the meeting, council members deliberated on six critical items: Protocol 29, Recommendation 203, Convention 190, Recommendation 206, Convention 191, and Recommendation 207. The discussions aimed to ensure Vanuatu's Labour policies align with international labour standards and address emerging workplace challenges.

The TLAC emphasized the importance of adopting these ILO instruments to strengthen worker protections and promote fair and safe working conditions across all sectors in Vanuatu.
